<b>What will I study?</b>	<ul style="list-style-type: none"><li>• General Management 1 [Accounting &amp; Financial Reporting] [PBE]</li><li>• General Management 2 [Economics, Finance &amp; Marketing] [PBE]</li><li>• General Management 3 [Strategy, Project Management &amp; Internalisation] [PBE]</li></ul> <p>[ PBE] = Paper-Based Examination    [PBD] = Project-Based Dissertation</p>
<b>How is the course assessed?</b>	<ul style="list-style-type: none"><li>• By a three-hour Paper-Based Examination Only</li></ul>
<b>Any Exemptions?</b>	<ul style="list-style-type: none"><li>• Qualifications acceptable to the University [ACCA, CIMA, ICSA, IFA, AAT etc.]</li></ul>
<b>Any deadlines I should know about?</b>	<ul style="list-style-type: none"><li>• Register at least 3 months prior to exam. sitting [held in June &amp; December]</li></ul>
